2022 Chairman's Award

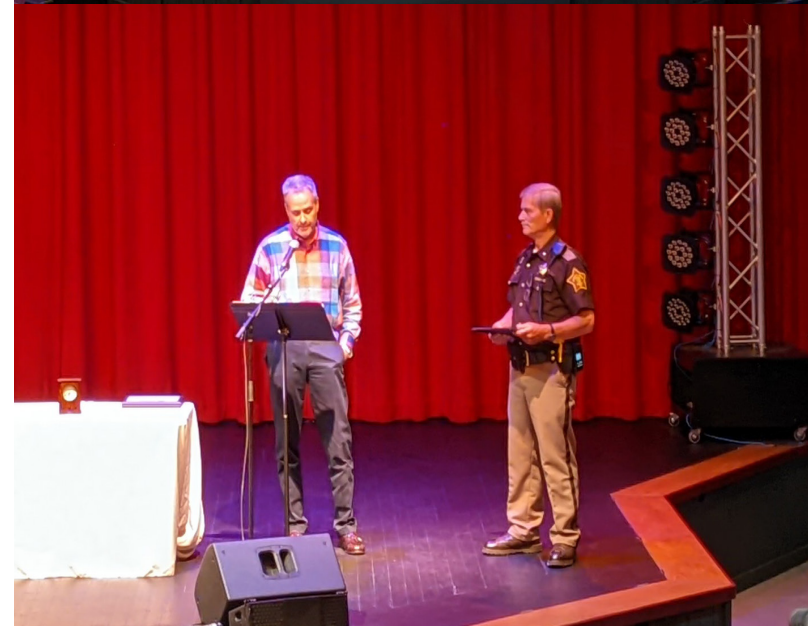

2022 Environmental Leadership Award

Bill, Pat, Andrew, and Matt Lloyd started this award and fund in 2007. It honors a person or organization which protects or improves our greatest natural assets.

The Brown County Public Library was recognized for their newly installed solar panel project. The 324 solar panels in the project are expected to produce up to 162,000 kilowatt hours of electricity annually offsetting more than 115 metric tons of carbon dioxide annually, the equivalent of removing 25 automobiles from the road each year.

Story Inn for Early Education

With the committed match, we raised \$20,385. Of that, \$12,000 was given directly to expenses at the Early Education Center while the remainder supported Pre-K scholarships.

Brown County Inn for Habitat for Humanity of Brown County:

Brown County Early Education

In 2022, we continued our support of PreK scholarships in collaboration with Brown County Schools. It's well documented that a good educational foundation is crucial to a successful life and these scholarships help ensure equal opportunities and access for all Brown County children. The opening of the Brown County Early Education Center (EEC) in 2022 was a huge step towards providing care in our county.

In 2020, we surveyed parents across the county to better understand the current state of early childhood education in our community. Parents who had children under the age of 6 were asked to identify their current method of child care. We learned that most parents are relying on family, friends, and neighbors to watch their young children. Many parents acknowledged it is difficult to find someone they can trust and that they fear their children are missing out on learning and social opportunities available in more structured environments. Our work has led us to better understand the issues surrounding child care affordability and availability in Brown County, the necessity of a well-functioning child care sector for working families and workable solutions that allow us to collectively address the issue in a meaningful way.

Thanks to grant dollars secured from Regional Opportunities Initiative, a wing of the former Brown County Intermediate School became the new Brown County EEC. As a part of this work, Brown County High School has adopted a Next Level Program of Study in early childhood education. Participating students will have the opportunity to gain practicum hours at the EEC and graduate with a Child Development Associate certificate which is the base level credential for our childcare workforce. Students gaining an understanding of early childhood development and principles of learning will also have the foundation for careers in psychology, social work, speech-language pathology, occupational therapy, developmental pediatrics, and pediatric nursing — just to name a few. In the first fall of the program, seventy students signed up for the program.



Growing Philanthropy with Art and Nature

When it comes to improving the environment, it's great to start in your own backyard. That is the approach the BCCF Board of Trustees has taken with their commitment to native plants to help pollinators on their property at North Van Buren St, creating an appealing blend of art and nature.

With a large concrete retaining wall selected for a mural, we found a way to add art to our campus while also installing a pollinator garden around it.

Partnering with Brown County Pollinators (BCP) to construct a garden surrounding the wall, we have created a space for pollinators to be featured in art and in nature.

Working with BCCF, local volunteers, and a volunteer force from Cummins Inc., the pollinator space is a work in progress with hopes to be fully established in just a few years. The art portion is complete with a stunning mural featuring milkweed pollinators. The artist, Christina Hollering, has a history of using native plants and species in her work.

Fabulous 50 Chooses 2022 Award Winners



The Fabulous 50 group has awarded local organizations more than \$180,000 in the community since they began in 2013. The group has nearly doubled in size, starting with 49 members and is now sustained by about 90 individuals. An offshoot of the group is the Magnanimous Men, which has four members.

Each member of Fabulous 50 gives \$200 per year to the giving circle. Each donor writes a cause she would like to support on a slip of paper, and three slips are drawn from a basket to be contenders for that year's donations. Then, members make pitches to the group about why their nominee is deserving. Out of those three suggestions two are chosen for awards.

BCCF acts as a support and liaison between the donor group and fund recipients.

Group founder Betsy Lease said the Brown County Community Foundation is a “tremendous partner” in handling the accounts for the Fab 50, which “legitimizes the gift.” Every year out of the Fab 50 funds, the group also gives to the BCCF sustainability fund.

“That was one of the things that when I founded (the Fab 50) I thought, the (BCCF) is the major philanthropic group we have, but they need support,” Lease said.

Congratulations to the 2022 Lilly Scholar

Since 1998, BCCF has had the privilege of awarding Lilly Endowment Community Scholarships to 40 Brown County High School Graduates. This annual scholarship pays a four-year tuition and a stipend for books and equipment to the Indiana public or private college of the student's choice.

The scholarships are the result of a statewide Lilly Endowment initiative to help Indiana students reach higher levels of education. The Endowment believes that education at all levels is important to the personal, civic and economic well-being of Indiana's residents and communities. This program aims to encourage many of Indiana's most talented students to attend one of the state's higher education institutions and, ultimately, pursue careers in Indiana.

Our 2022 winner, **Annika Evenson**, received a full four year scholarship to the University of Evansville.

Scholarship Funds

The Brown County Community Foundation (BCCF) is a crucial part of the educational journey of many Brown County students. Since the inception of the Foundation 30 years ago, supporting the community through scholarships has been an integral part of our work. The first BCCF endowment was opened by the late Michael O'Hara in 1994 to honor the only Brown County casualty in the Vietnam War, Larry C. Banks. In the fall of 1993, O'Hara was told that the Foundation was being formed. "It was just a match made in heaven," O'Hara said. "We needed somebody to manage the scholarship, and they needed an account. It really worked out for us. The timing was just perfect." The Larry C. Banks Bronze Star Memorial Scholarship Fund was created and still exists today, providing scholarships to graduates of Brown County High School who pursue vocational education or a 2-4 year degree.

BCCF's scholarship program consists of a variety of scholarship funds established by donors to help students in Brown County further their education. A list of all the scholarship funds can be found on page 28. Students who meet the eligibility requirements of these scholarships may apply to the program and may be awarded a scholarship from one or more different funds. This process occurs annually with the support of a committee of volunteers at BCCF.

Additionally, through BCCF's affiliation with The Lilly Endowment Inc., forty Brown County residents have received four-year full-tuition scholarships through the Endowment's Community Scholars Program. BCCF is committed to helping the students of Brown County pursue a variety of degrees and professions. As BCCF continues to build new scholarships, their endowment will grow and provide deep financial impact for the diverse educational needs of local students. Thanks to local donors who make the scholarships possible, BCCF is helping to educate students for a better future.

Our 2022 winners, Del and Letty Newkirk, have contributed decades-long service to the art and civic vitality of the community. Del is the founder and first CEO of the Brown County Community Foundation as well as the founder and first president of the Rotary Club of Brown County. He has extended his volunteering and expertise to organizations like the Sycamore Land Trust, and has raised millions of dollars for charitable efforts. He was awarded the Sagamore of the Wabash from Governor Frank O'Bannon in 2003.

Letty, a former journalist, has been a valuable member of the Eskenazi Art Museum's docent corps for more than 15 years, serves on the board of Indiana Heritage Arts, and is currently leading development of a documentary film "Brown County Art & Artists" which highlights current Hoosier artists.

Del and Letty Newkirk were directly involved in founding non-profit organizations that both fundamentally changed this community and in doing so, created legacy organizations that will continue to enhance our quality of life for years to come.

Organizations for Nonprofit Excellence

The BCCF is especially proud of launching ONE, the Organization for Nonprofit Excellence, implemented under the leadership of Community Foundation Board member Debbie Kelley.

Established to build the skills and capacity of Brown County nonprofits through education, networking, strategies, and resources, ONE has enjoyed enthusiastic participation. In its inaugural year three networking sessions provided an opportunity for representatives from area nonprofits to meet, share information, and build relationships. Three training courses provided attendees guidance about fundraising for small nonprofits and an overview of securing major gifts.

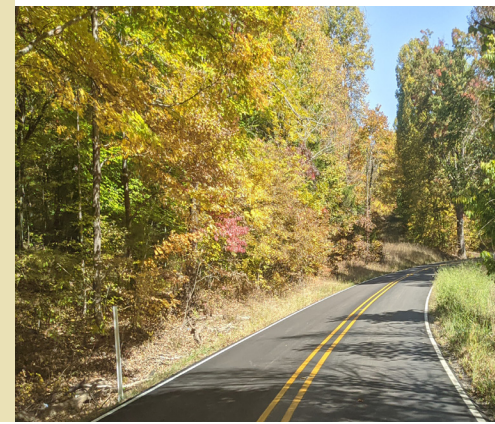

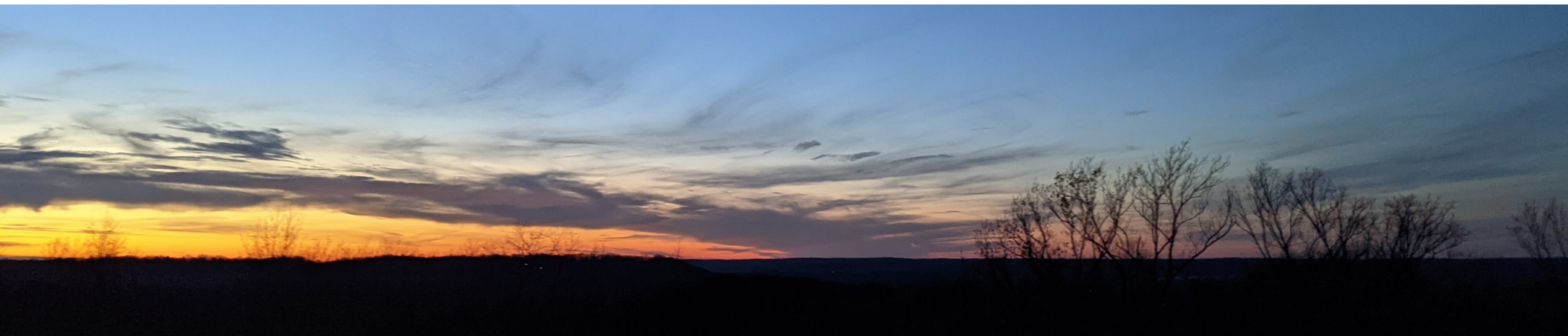

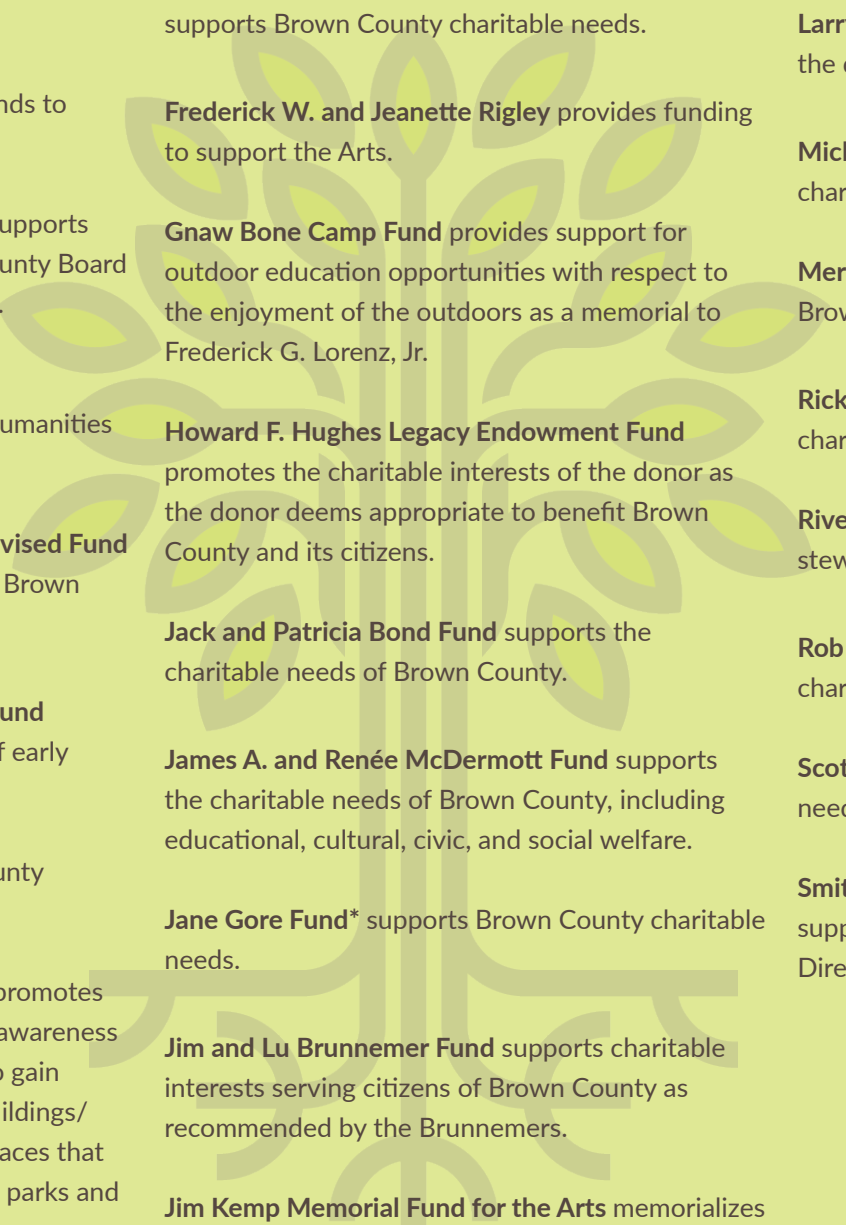
