### From the CEO



Oh, what a year it's been. If you're still grappling with the impact of the pandemic, calculating losses over the past year, and making sense of it all, you're not alone. Some have called 2020 a "lost year". Indeed, we have all lost something, or someone, while our sense of time was warped and the months lurched ahead. Yet throughout this detour from ordinary life, the folks at BCCF have worked harder than ever to meet the pressing needs of our community.

We are a founding member of the county's COAD (Community Organizations Active in a Disaster). A disaster response team that has now distributed over 160,000 pounds of food. We established a Rapid Response Fund which has provided over

\$188,000 to projects like a refrigerated truck for food distribution, personal protective equipment for first responders, mobile devices for telehealth services, and much more. We also applied for and administered a state COVID-19 Small Business Grant Program which provided \$250,000 to local businesses dealing with the economic impacts of the shut down. These impacts extended to the global economy as we witnessed paralyzed businesses, supply shocks, and increasing debt.

Our endowment managed to weather the storm, ending the fiscal year up +7.77%.

While dedicating much time and energy toward COVID-19 response, BCCF has continued to support ongoing community programs. In 2020, we distributed over \$1.4 million in grants and scholarships while also obtaining funding from Regional Opportunities Initiative to support our preschool scholarship program and the creation of a new birth-to-five early learning and childcare center. We want to thank you for your continued support during a challenging year. Through teamwork, dedication, imagination, and hard work, our community has risen to the challenges presented by the COVID-19 pandemic. We remain committed to the belief that we are stronger together.


# **Volunteer for Our Brown County**

# **Rapid Response for Our Brown County**








# **COVID 19 Pandemic Response and Support**

As 2020 progressed, BCCF monitored the rapidly evolving circumstances surrounding the novel coronavirus (COVID-19) and its potential impact for our community. Unprecedented times commanded BCCF into a leadership role to unite our community for the greater good. We worked with the Indiana Office of Community and Rural Affairs, the United Ways of Bartholomew and Monroe counties, The Lilly Endowment, and local government to understand the needs of our community, to adapt in response to those needs, and to develop strategic investments and innovative solutions. Anchored by OUR deep roots in this community and in OUR commitment to help create lasting change, we were ready and willing to help whenever and wherever our community needed it.

# **Planned Giving For OUR Brown County**

Virtually any asset of value can be given to the Community Foundation.

Regardless of the size of your estate, by contacting your attorney and creating or updating your will, you can provide for your beneficiaries while leaving a personal legacy to support a cause that has meaning to you.

### Write Your Will

Use will planning as an opportunity to decide what type of legacy gift best suits your estate planning goals.

### Life Insurance

By naming the Foundation as the irrevocable owner and beneficiary of a life insurance policy, a donor is entitled to an immediate tax deduction on the cash value of the policy, with future premiums paid by the donor being deductible as charitable gifts.

### **Charitable Bequest**

You can bequest a certain dollar amount, a particular percentage, or certain property.

This is the most popular form of charitable bequests. Indeed, gifts of specific properties to charity may be uniquely appropriate bequests, both for tax and personal reasons.

### **Trusts**

Trusts have become an increasingly important tool in estate planning, especially in the field of charitable giving. Individuals form different types of trusts to:

- Avoid probate administration
- Secure income, gift and estate tax savings
- Decrease gross estate size
- Assure preservation of wealth and to protect assets from creditors
- Diminish asset management responsibilities
- Control disposition of assets to beneficiaries

# **Do Something** \$11,000

Do Something—and its Launch House initiative—serves those needing hope and freedom from Substance Use Disorder. Launch House is a non-residential resource center centrally located in Brown County, opened its doors January 2020 on Gould Street in Nashville. These funds will support Hopefest, a late summer annual event to celebrate recovery.

# **Brown County Humane Society** \$5,500

To ensure extraordinary medical needs of shelter cats and dogs can be met. Examples include, surgeries for broken bones, tumor removal, gastric torsion, and treatments for disease. They spends anywhere from \$11,000-\$18,000 per year on extraordinary veterinary services.





# **Congratulations to Our Lilly Scholar!**

Since 1998, Brown County Community Foundation has had the privilege of awarding Lilly Endowment Community Scholarships to 39 Brown County High School Graduates. This annual scholarship will pay full four-year tuition and \$900 a year for books and equipment to the Indiana public or private college of student's choice.

The scholarships are the result of a statewide Lilly Endowment initiative to help Indiana students reach higher levels of education. Indiana ranks among the lowest states in the percentage of residents over the age of 25 with a bachelor's degree.

To date the Lilly Endowment Community Scholarship Program has awarded 4,769 full-tuition scholars and over \$405M in scholarship tuition

# **Scholarship Funds**

Education has been a primary focus of the Foundation's efforts since its founding in 1993. In fact, the first endowment fund established was the Larry C. Banks Bronze Star Memorial Scholarship.

The Foundation manages several academic scholarship funds, many established expressly for Brown County High School graduates. However, others, like the Banks Scholarship, focus on vocational education and/or non-traditional students.

We are proud to report that the Community Foundation administered 31 scholarship funds to very impressive and deserving students in Brown County. We awarded over \$42,000 in scholarships in addition to the Lilly Endowment Community Scholarship.

She is a past President and past Secretary of the League, and an active volunteer in projects from Voter Registration to Voter Education and more. Last year, she undertook a special project of researching and writing a history of suffragettes in Indiana, in honor of the 100th birthday of the League of Women Voters and the ratification of the 19th Amendment, giving women the right to vote. She presented this history on the Brown County Radio Hour, to the Brown County Genealogy group, and at the Centennial Tea hosted by LWVBC. She is often found researching and writing articles on issues important to voters and works to protect voters rights.

She is passionate about advocating for peace, for education, for human rights. And she puts her beliefs in action, making sure local Brown County elderly friends get the support they need. She has been an active volunteer throughout Brown County for years. She has served on the Board of the BC Community Foundation. She is a key player in Brown County Radio Hour, working hard to make sure Brown Countians have access to wonderful Brown County news, music and stories.

In acknowledgment of his remarkable record of service, Mr. Rudd was the first recipient of this award.

on youth development. He and his wife Mary have chosen to live in Brown County since 1989 and we are fortunate to have them as members of our community where Teed has continued his life-long commitment to service before self.


